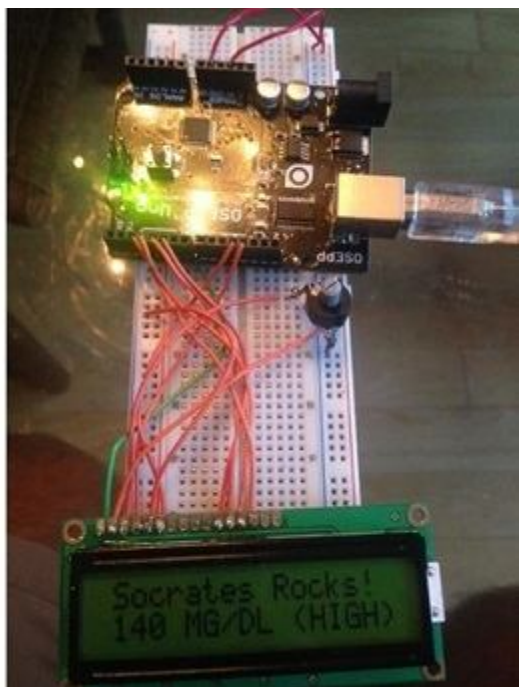

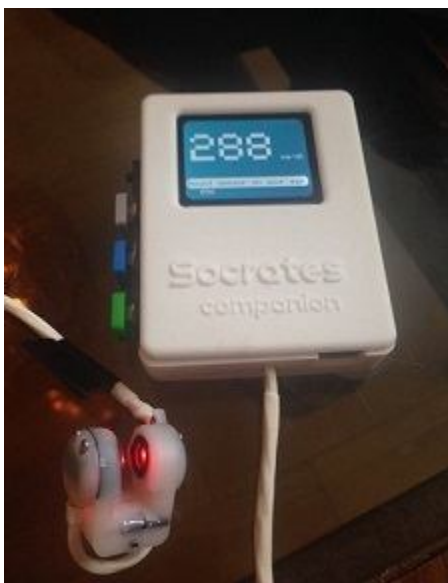

## Risks and challenges

Every newly developed electronic device has challenges. Currently, Companion is in its 4th generation of development. Internally, we call this - Companion Thing 4. Thing 4 is in the picture above and is what Scott Smith demonstrates in the video. Yes, Scott is able to test his blood sugar without pricking his finger - accurately and painlessly.

Now that we have a working prototype, our next challenge is FDA approval. Socrates is committed to producing a safe, effective, accurate and pain-free solution for diabetics who must check their blood glucose levels several times a day. Getting FDA approval is the top priority for Companion.

Clearly, not receiving FDA approval is a risk. That is why Socrates has several consultants and advisors to guide us every step of the way through this process. We are confident that this funding will allow us to make a significant step toward receiving FDA approval and bringing what will be a *life-changing* product to the market for diabetics...not only in the United States, but around the world.
